**St Helena, Ascension and Tristan Da Cunha Constitution Order 2009****CHAPTER 1****ST HELENA****Appointment of Acting Judge**

**WHEREAS** Part 6 of the Schedule to the St Helena, Ascension and Tristan da Cunha (Constitution) Order, 2009 establishes a Supreme Court for St Helena, and section 84(1) thereof provides for the appointment of a Chief Justice and such number of other judges of the said Court as may be prescribed by law.

**AND WHEREAS** it is provided by section 90(2) thereof that the Governor may, acting in accordance with the recommendation of the Chief Justice, appoint such acting judge of the Supreme Court.

**AND WHEREAS** the Chief Justice Rupert Trevelyan Jones has recommended the appointment of Judge Rhona Campbell as acting Judge of the Supreme Court of St Helena for all matters incidental to the case of M Peters v the Attorney General (on behalf of the Directorate of Health and Social Care) and Dr S V Bran on St Helena.

**NOW THEREFORE**, in exercise of the powers vested in the Acting Governor and acting in accordance with the recommendation of the Chief Justice, I Stephen James Thwaites, Acting Governor, hereby appoint under section 90(2) Judge Rhona Campbell to act as a Judge of the Supreme Court for the above named case.
