NOTES TO ASSIST IN COMPLETING THE NOMINATION FORM

These notes are not part of the official form, but are added to assist potential candidates and their sponsors/supporters. In case of doubt, the Ordinance and Regulations should be consulted.

- 1. Full Name of Candidate: Insert the full / complete name (including title Miss, Mrs, Mr, Ms, Dr, etc) of the person standing for Election to Council.
- **2. Declaration by Candidate:** The person standing for Election to Council declares, in this part, that s/he is willing to be nominated.
- **3. Full Names of Sponsors:** Two people, whose names are included within the Register of Electors effective from 1 July 2025, published in Extraordinary Government Gazette No 71 dated 30 June 2025, may sponsor the person being nominated. A person may not sponsor more than 12 persons in this General Election. In signing the form, a person declares that s/he is not acting as sponsor for more than 12 candidates.

These two signatures must be witnessed by the Returning Officer (or an Assistant Returning Officer) or by a Justice of the Peace (see below for names of currently available Justices of the Peace).

4. Full Name of Supporters: Five people, whose names are included within the Register of Electors effective from 1 July 2025, published in Extraordinary Government Gazette No 71 dated 30 June 2025, may support each person being nominated. A person may not support more than 12 persons in this General Election. In signing the form, a person declares that s/he is not acting as supporter for more than 12 candidates.

Each signature must be witnessed, but one supporter can witness the signature of another supporter. The candidate should not witness any of the signatures.

So a total of at least nine people must sign the form:

- The candidate (whose signature does not need to be witnessed)
- Two sponsors
- The Returning Officer (or an Assistant Returning Officer) or a JP who witnesses the signatures of the sponsors
- Five supporters (whose signatures must be witnessed, but one can witness the signature of another).
